We want you to know what to expect before entering.

- As of the publishing of this premium, we expect the shows to go on as described. All show decisions will be in accordance with Massachusetts state and local guidelines in place at the time of the event.
- **Closing Date: Wednesday, May 19, 2021 at 12:00 Noon.**
- **LIMITED ENTRY: AM Specialty 100, PM Specialty 100.**
- In the event that the shows need to be canceled because of virus restrictions, we will notify all exhibitors via email **no later than the closing date.** (Checks will not be cashed.) After closing, the refund policy as detailed in this premium will remain in effect.
- Colonial Shetland Sheepdog Club is making every effort to supply a safe trial environment. However, exhibitors are entering the events at their own risk.
- These shows are held in cooperation with Ladies' Dog Club. All rules and restrictions of Ladies' Dog Club must be followed. (See pages following.)

Other things you can expect on show days:

- **MOST IMPORTANT: If you are exhibiting signs of illness, have tested positive or have been otherwise told to self-quarantine due to known Covid-19 exposure, please stay home.**
- Parking: Leave some "social space" between cars when parking, expect to work from your vehicle. RV Parking will be available as detailed in the premium.
- Social distancing guidelines are to be followed with people outside your immediate social or family circle. This includes interactions with judges and club members.
- Masks are required to be worn at all times on the show grounds as well as in and around the ring.
- Check-in and armband pick-up area will be clearly marked.
- This event is closed to spectators.

NOTICE – WAIVER OF RIGHTS

All persons attending these dog shows hereby waive any claim for damages against the AKC, any AKC clubs holding events, MB-F, all other contracted staff, WDC and its employees, and any workers and volunteers.

IF YOU ARE NOT FEELING WELL, OR HAVE BEEN EXPOSED TO ANYONE WITH COVID-19 WITHIN THE LAST TWO WEEKS, PLEASE STAY HOME TO TAKE CARE OF YOURSELF AND PROTECT OTHERS.

The following show rules incorporate State and local rules in force at the time of Event approval and therefore are subject to change. The Club may add, remove or modify any of the rules based on new guidance from the CDC, State, local and Wrentham Developmental Center ("WDC") officials under the current COVID climate and/or for the safety and comfort of the exhibitors and dogs.

- Cooperation with all Club members and show officials, RV/parking personnel and WDC Security including following instructions and directions is required
- No Spectators Are Allowed.
- No electricity or grooming tents are available. Please groom at your RV or motor vehicle. Ringside crating will be available in designated areas under the ring tents for 15 min. before/after your breed judging. No grooming, please. Individual attached in-crate fans only.
- A signed COVID-19 waiver will be required for admission to the show grounds. Upon submission of the signed waiver and a temperature check, a colored wristband will be issued. Only one waiver required for 1st show. To receive a different colored wristband for each subsequent day, you must pass a temperature check and be wearing the intact wristband from the prior day. No wristband, no entry, no exceptions.
- Masks (covering nose and mouth) must be worn at all times by everyone over 2 years, except while in your RV or motor vehicle. Vented masks, shields and gaiters are not acceptable. Please bring your own masks, hand sanitizer, cleaning wipes, etc. for personal use.
- Wash your hands frequently. There are numerous sanitizing tables set up throughout the show site for your use.
- This is a Show & Go. No group gatherings are allowed on the grounds. All attendees must adhere to the 6-foot social distancing guidelines even when wearing a mask.
- Each ring will have a separate entrance and exit(s), and tables for ring steward at entrance and judge at exit. Only the ring steward will have access to the steward's book, so please come prepared with a list of your armband numbers.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- No chairs will be allowed around the rings or under the tents except for Stewards and Judges.
- We will have committee members circulating to ensure that everyone understands the rules and to answer questions. We ask that you honor any request made of you.

THIS CLUB DOES NOT AGREE TO ARBITRATION

Notice to Exhibitors

These shows will be governed by the rules and regulations of the American Kennel Club. Exhibitors are expected to make themselves familiar with the agreement of the AKC, referred to on the reverse side of the entry blanks that accompany this Premium List.

Ladies' Dog Club, Inc. is not responsible for exhibitors' failure to obtain and familiarize themselves with the information and policies available in this Premium List.

- Grounds will not be available until 3PM on Thursday.
- The Club and its members will not be responsible for the loss of or damage to any dog exhibited, or for the possessions of any exhibitor, whether the result of accident or any other cause. It is distinctly understood that every dog at these shows is in the care, custody and control of his owner or handler during the entire time the dog is on the show premises.
- The club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause and no one shall have any claim or recourse against the club or any official thereof.
- Dogs not entered will not be allowed on the official show grounds.
- All claims for trophies and other prizes must be made in the ring before the completion of the judging of the breed and the superintendent advised at once in the event of any discrepancy. LDC reserves the right to substitute any unavailable trophy offered with one of equal or greater value. Trophies offered and not awarded will become the property of the club. None will be mailed.
- The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children at these shows.
- No extended Flex-Leads are to be used on the grounds.
- No dogs allowed in the ring for practice.
- Private exercise pens will be allowed only at RV or motor vehicle set up.
- No Camper Hookups.
- Do not leave dogs in closed vehicles in warm weather. The Club reserves the right to remove from a vehicle dogs that appear to be in danger of overheating. Any damages are the responsibility of the vehicle owner.
- No smoking under the tents.
- No alcoholic beverages may be consumed on the show grounds.
- No puppies under the age of six (6) months may be on the grounds.
- It is the responsibility of each exhibitor and guests to observe all parking signs and directions from ground staff, especially near the Wrentham Developmental Center buildings or their parking areas. No parking in right of way or roads.
- No gasoline or diesel generators are permitted within 100 feet of any tent in which these dog shows are conducted.
- All persons attending these dog events hereby waive any claim for damages against the Ladies' Dog Club, Inc. or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

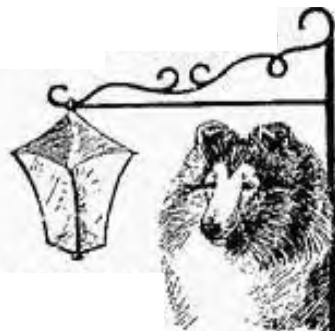

Veterans class*: Classes for dogs and bitches seven years of age and over.

*The American Kennel Club allows spayed bitches and castrated dogs to be shown in the Veterans Class at Independent Specialty Shows, and are eligible for competition in Best of Breed Competition if otherwise undefeated the day of the show.

Chapter 11, Section 8 of the Dog Show Rules.



Puppy Sweepstakes

Sweepstakes are open to Shetland Sheepdog puppies 6 months and under 18 months. Each entry must also be entered in the Regular Class in one of the two shows. Champions of Record are NOT eligible to compete. Indicate Sweepstakes on the regular entry form in the space for additional classes (state age). Cash prizes will be awarded to Best in Sweepstakes and Runner-Up to Best in Sweepstakes only.

PUPPY CLASSES (for Dogs and Bitches)

Puppy, 6 months and under 9 months
Puppy, 9 months and under 12 months
Junior, 12 months and under 18 months

The Puppy Sweepstakes entry fee is \$10.00.

The amount of money received from each separate sweepstakes fees will be divided as follows: 40% retained by the club for expenses, with 60% to be divided between the two winners of the sweepstakes as follows:

Best in Sweeps 70%
Runner Up 30%

Junior Showmanship

Novice class: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three first places in a Novice class at a licensed or member show.

Open class: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have won three first places with competition present in a Novice Junior Showmanship class at a licensed or member show.

Master class: This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and, who at the time entries close, have won the 10 first place wins in an Open class with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

Junior Handlers must include their AKC Junior Handler Number on each entry. You may obtain your junior identification number by calling the AKC at (919) 233-9767. Be sure all information for Junior classes is entered on the front and back of the entry form.

Bitches in season are not eligible. At Specialty shows, dog must be of the breed for which the show is held.

If you use an entry service (superintendent, online entry or fax service) other than the Show Secretary listed in the premium, please be aware of their terms additional charges and delivery policies. Entries are processed in the order that they are received at the address of the Show Secretary.

Express/Overnight entries must be sent with **NO SIGNATURE REQUIRED**.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules on the back of the official AKC entry form are NOT ACCEPTABLE. Entries received without fees, postdated checks, returned checks or declined credit cards do not constitute a valid entry fee. The Show Secretary will add a \$30 collection fee to the amount of each returned check. Refunds of \$8 or less will not be issued due to the cost of processing.

PLEASE make your entries correct and legible. Illegible entries cannot be processed and will be returned to the exhibitor. Owners/Agents are responsible for errors on entry forms. (Rules Applying to Dog Shows, Chapter 11, Section 6). Each Owner/Agent listed on the entry form and/or individual responsible for the dog at the show is bound by the Certification and Agreement on the front and back of the entry form regardless of who may have completed and submitted the form. No entry fee will be refunded in event of such errors, or cancellation of entries after the published closing date. No refund for duplicate entries. No entry will be accepted which specifies any conditions as to its acceptance.

An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry, \$3.00 for each additional entry in any Licensed or Member Club Rally Trial. All Recording and Event Service Fees are paid to the American Kennel Club. There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions. (Rules Applying to Dog Shows, Chapter 11, Section 2)

Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.

No entry may be changed or canceled unless notice of the change or cancellation is received in writing by the Show Secretary prior to the closing date and hour for entries, except that a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another or between the Puppy and Twelve-to-Eighteen Month Class at a show prior to the judging. A dog determined to be ineligible, by its owner/agent, for the class in which it has been entered may be transferred to an eligible open class at a show prior to the judging of any regular conformation class within the sex of that breed or variety, and that dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for a show but whose Championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging at the show. No dog may otherwise be transferred to another class. Owners are responsible for errors in the entry forms, regardless of who may make such errors.
